## Side Street Artists - Event Rules

1. All Side Street Artist events are open to local artists from Fort Myers to Naples by application approval only.
2. All event fees non-refundable.
3. Artist display spaces are either one six foot (\$28), one eight foot (\$35) or two (\$50) eight foot indoor display tables or an outdoor 10' x 10' tent space (\$15). All art must be restricted to your assigned space. Display tables (for indoor booths) and chairs are provided, if desired. Tents are not provided.
4. Side Street Artists events are sponsored in part by the *Naples Daily News Newspapers in Education program*. They provide advertising, and in exchange a raffle of art is held at each Side Street Event to support their program which benefits our local schools. ***A minimum donation of one piece of art from each artist is requested for each raffle.*** Applications will be approved based in part on the ability to donate art for this raffle, as this keeps our organization alive and provides huge advertising assistance for the events.
5. All artists are responsible for their own setup and display space cleanup. All artist display spaces must be completely set up no later than 9:45 am on the day of the event. All artist vehicles must be parked in assigned spaces by 9:30 am. Vehicles with trailers are not allowed in venue parking area due to space restrictions.
6. Artist display spaces must be disassembled and cleaned thoroughly no later than 5:30 pm on the event day. Please check in with assigned event organizer before you leave. Please help us keep costs down by taking good care of this venue property!
7. All artists are responsible for being present in their display spaces during the hours of the venue.
8. Artists not present at venue property by 8:30 am on the day of the event will be deemed a "no show", and their space and booth fee forfeited. If you are going to be delayed, please contact the organizer assigned to the event by 8 am on the day of the event.
9. Artists may share spaces. Each artist must sign the application, provide information about their art, and be approved by event organizers.
10. All artists are responsible for their own sales and for collecting and reporting the required 6% Florida sales tax.
11. All artists agree that their artwork is original and created by the artist. Sale of non-art items is prohibited. Commercial dealers and crafts not deemed "artist works" (such as kits, molds, heirloom items and scrapbooks) are prohibited.
12. All events will be held "rain or shine".
13. By signing this document, you agree to allow M.E. Parker Productions and Side Street Artists to use any written information or photographs submitted by you for advertising purposes including but not limited to the Side Street Artists web site, online social networking, such as Facebook, print media, flyers, televised & radio advertising.
